

Before me the undersigned Fourth Circuit Judicial Officer, in and for Duval County; notary public; or law enforcement officer personally came B J WOLCOTT, who, being duly sworn deposes and says that he/she has reason to believe and does believe that one **MARK ALAN MILTON**, described as follows: Last known address: **6961 LENOIR AVE E #129, JACKSONVILLE, FL 32216**; Race: **WHITE**; Sex: **MALE**; DOB: **LEO and ASA**; Ht: **6' 01"**; Wt: ; Hair: **GRAY/SALT & PEPPER**; Eyes: **UNKNOWN**; Scars, Marks: ; did in Duval County, Florida, on **April 09, 2019**, commit the below listed offense(s), contrary to the provisions of Florida Statutes:

- 1) 800.03, EXPOSURE OF SEXUAL ORGANS; M1

Affiant's reasons for so believing are as follows:

On **04/09/2019**, at **2210** hours, Patrol Officers were dispatched to **6961 E Lenoir Avenue (Extended Stay)** in reference to lewd exposure by a guest at the hotel.

Upon my arrival, the complainant (**Autumn Brown**) stated that a man/suspect (**Mark Milton**) was observed exposing his sexual organs by multiple people. The complainant said that the suspect was staying in room **LEO** and has been there since **03/10/2019**. The complainant advised the suspect would not close his blinds to the room while walking around the room naked. The complainant stated that the suspect advised her upon check-in for the room that he was police officer for the Jacksonville Sheriff's Office. Let it be noted the billing statement reflected the suspect worked for the Jacksonville Sheriff's Office.

*Note: Suspect is actually employed as a police officer with the University of North Florida.

Victim #1, **Vic Abuse Sex Off** stated she observed the suspect naked in the room looking out the window rubbing his privates. She stated that upon seeing her, he shut off his room light but returned to the window and continued to rub his privates while looking at her. **Vic Abuse** stated that on an earlier date the suspect was lying in bed naked with the window curtains wide open.

Victim #2, **Vic Abuse Sex Off** observed the suspect lying naked on his bed with the curtains wide open. The suspect was asked to close his curtains which he complied but opened them back open a short time later.

Victim #3, **Vic Abuse Sex Off** witnessed the suspect standing in his hotel window naked rubbing his penis. She stated that upon the suspect observing her, he moved behind the curtains with his penis still in his hand.

Victim #4, **Vic Abuse Sex Off** (Victim 4) stated she observed the suspect lying in bed naked with his window curtains wide open.

Victim #5, **Vic Abuse Sex Off** stated that she saw the suspect masturbating while she was sitting in the parking lot. She said that the suspect made eye contact with her and continued to stare at her while masturbating. **Vic Abuse** advised she yelled at the suspect to close the blind and turn off the lights but the suspect would not comply. She stated that she told management to call the police.

Sgt. E. Cayenne #6060 retrieved a statement from the suspect. Sgt. Cayenne read the suspect his Miranda rights. Post Miranda, the suspect denied all allegations.
